Dear Waseefa

I hope this finds you well.

The Boschenmeer Golf Estate, otherwise known as Paarl Golf Club, proposes to construct a Silt Trap within a watercourse on Erf 26055, Paarl (please refer to locality map attached) as part of the Boschenmeer Golf Estate. The reason for the Silt Trap is to ensure that silt that is currently being transported onto the Boschenmeer Golf Estate is trapped, so that it can be removed, before it reaches the instream irrigation storage dams on the Golf Estate. The

silt build up reduces the irrigation water storage capacity of the dams and causing irrigation water constraints for the Golf Course.

The footprint of the Silt Trap is proposed to be approximately 70m², please refer to isometric view of the proposed Silt Trap also herewith attached. The proposed Silt Trap does not trigger the provisions of Section 38 (1) & (8), but it would help a lot if I could get confirmation from Heritage Western Cape that an NID would not be required.
